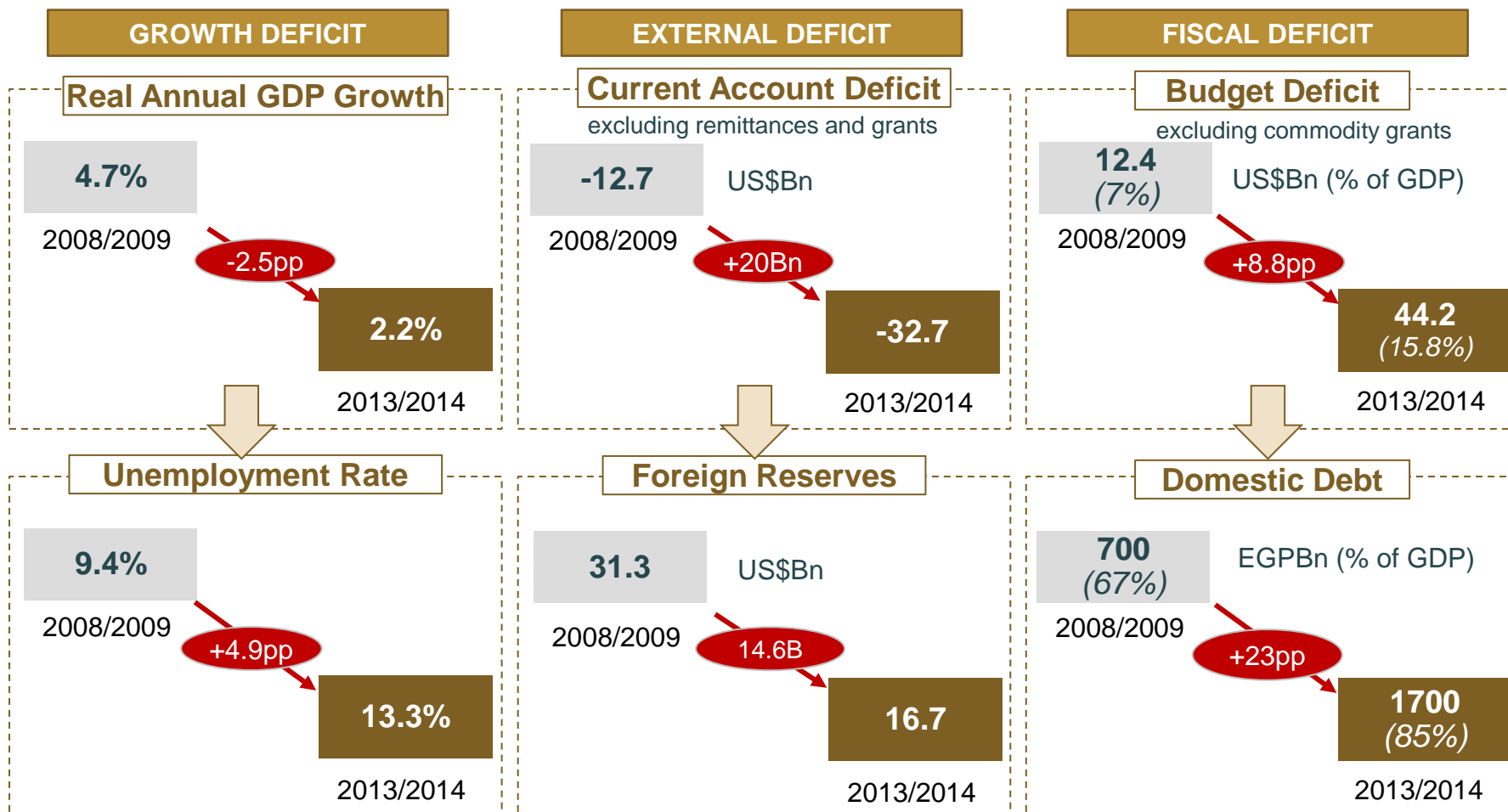

Political and social instability substantially slowed Egypt's growth and exacerbated structural imbalances

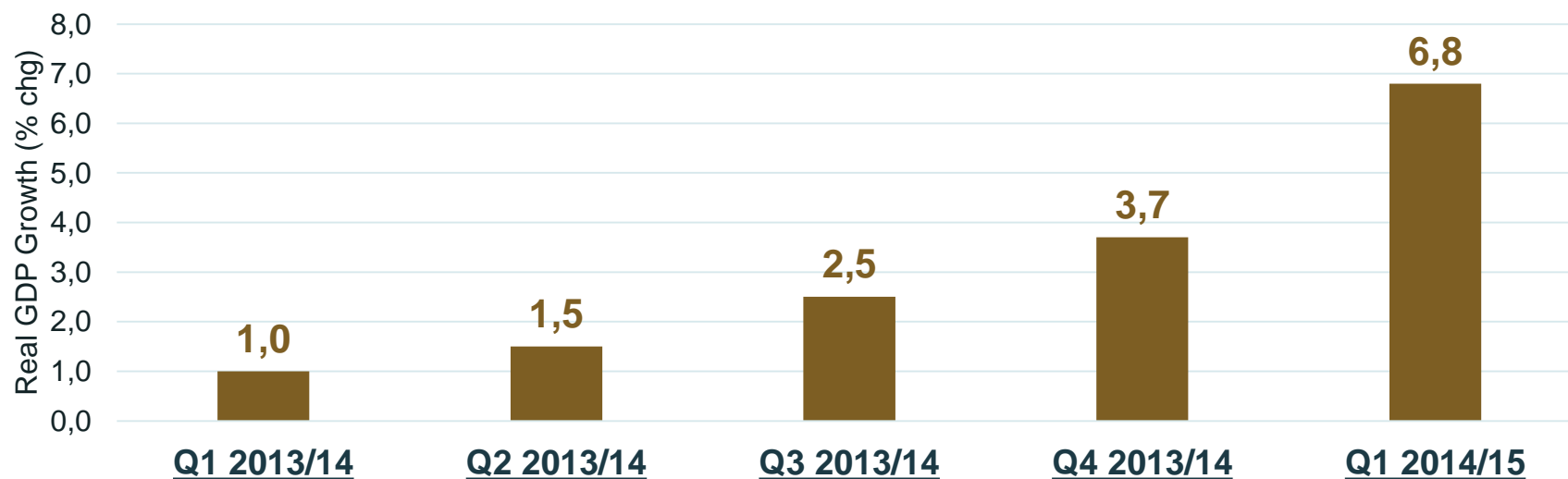


The recent return to political stability, fiscal reforms implementation, and inauguration of major projects have boosted confidence

GROWTH	■ Sustainable real GDP growth of 6% by FY 2018/19
FISCAL CONSOLIDATION	■ Fiscal consolidation to reduce budget deficit to 8-8.5% of GDP and government debt to 80-85% of GDP by 2018/19, in parallel with public financial management reforms
INFLATION	■ Reduction of inflation to 6-8% within the Central Bank of Egypt's comfort zone

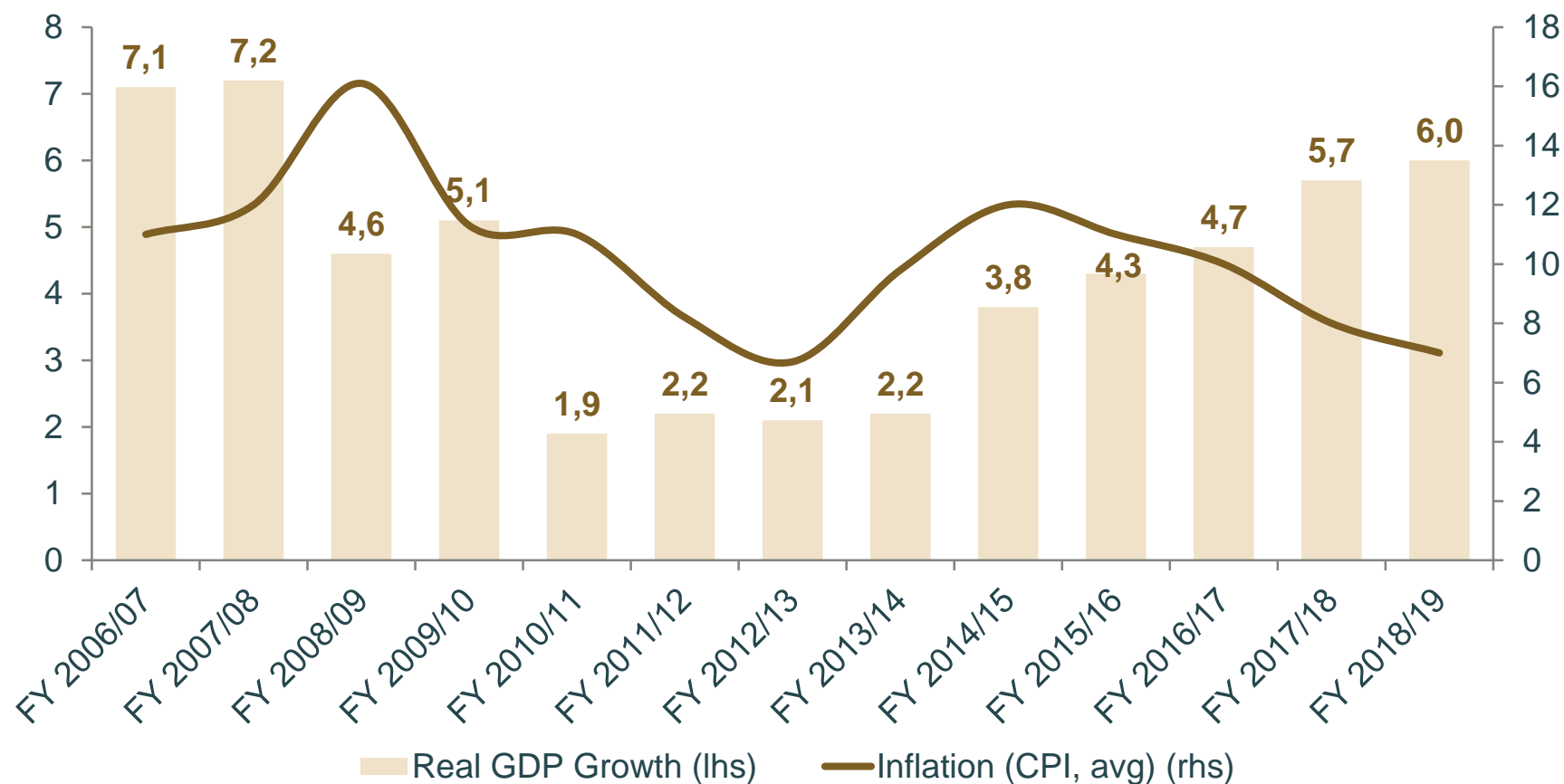

GDP GROWTH AND INFLATION ASSUMPTIONS



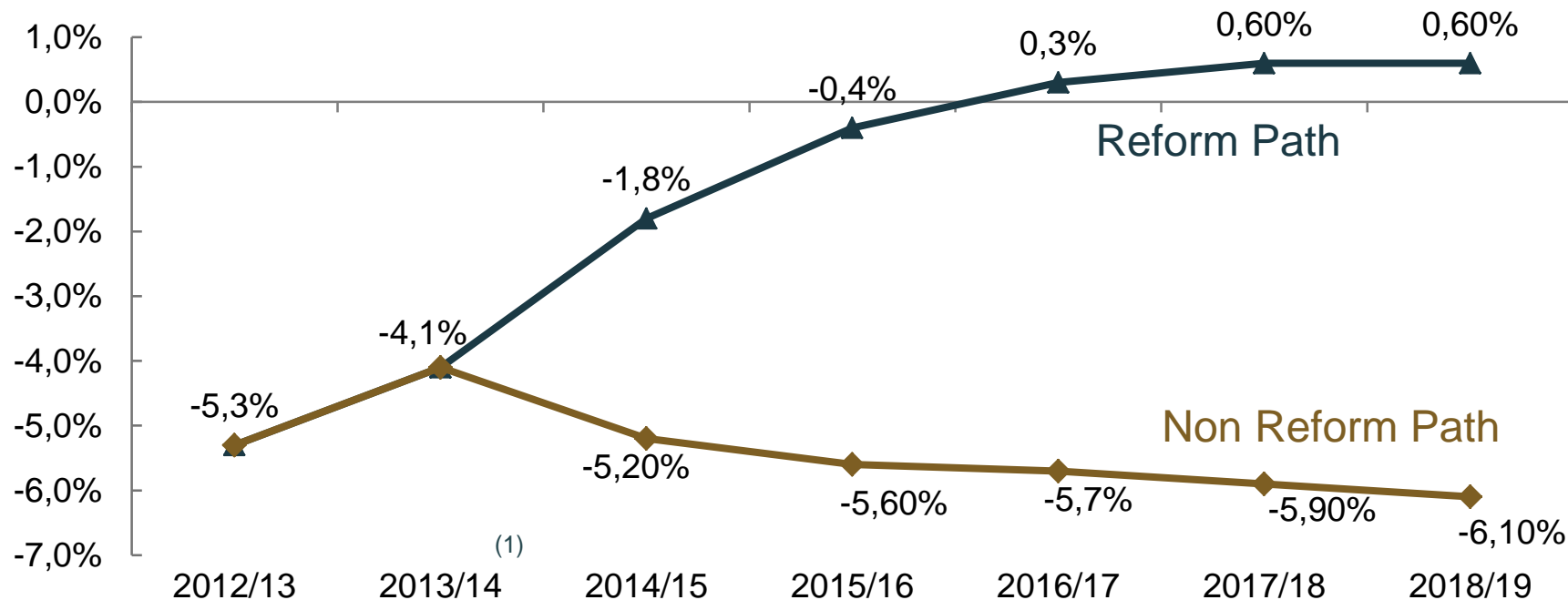

Fiscal consolidation will be achieved through revenue measures and an expansion of the tax base...



REVENUE MEASURES

Income & Capital taxes

- Broadening of the tax base to dividend incomes, capital gains and residents' incomes attained abroad (10% tax)
- Property tax: limitation of real estate tax exemptions to only one residential unit with a value of less than EGP 2m
- 5% increase of tax rates for corporates and individuals earning more than EGP 1m for a period of three years

Consumption taxes

- Higher excises taxes on cigarettes and alcoholic beverages
- Replacement of the GST system with the Value Added Tax (VAT)

Tax efficiency

- Simplification of tax regime for Small and Micro-Enterprises
- Settlement and collection of tax arrears and reduction of tax exemptions

Industry development

- New telecom licensing fees
- New mining tax regime

...and the redirection & reduction of wasteful expenditures towards productive and social priorities



EXPENDITURES RATIONALIZATION PACKAGE

Subsidies

- Phasing out of subsidies on all fuel products (other than LPG for needy households) and electricity to cost recovery levels in 5 years
- Enhancing the efficiency and flexibility of bread and food subsidies distribution schemes

Wage bill

- Obligation for all government entities to hire personnel under the regular system
- Suppression of the existing tax exemption on government employees' annual wage increases
- New hiring system and new civil servants' pay system limiting recruitments to a fraction of outgoing personnel and making the basic pay the bulk of civil servants' pay




Compensatory measures

- Three-year gradual increase in spending for health, education and R&D as per the new Constitution
- Expansion of the number of beneficiaries of the cash transfer program from 1.5 to 3 million households
- Redistribution of 50% of property tax receipts for localities and slums development



The government's program will create the platform for a more productive and dynamic economy

Key objective is to bring about the transformation of Egypt's economic base through reforms and projects that boost productivity and encourage sustainable private sector-led growth, thereby offsetting the impact of fiscal consolidation and gradually strengthening the external position

Business climate reforms constitute the cornerstone of policies to make the investment program a reality



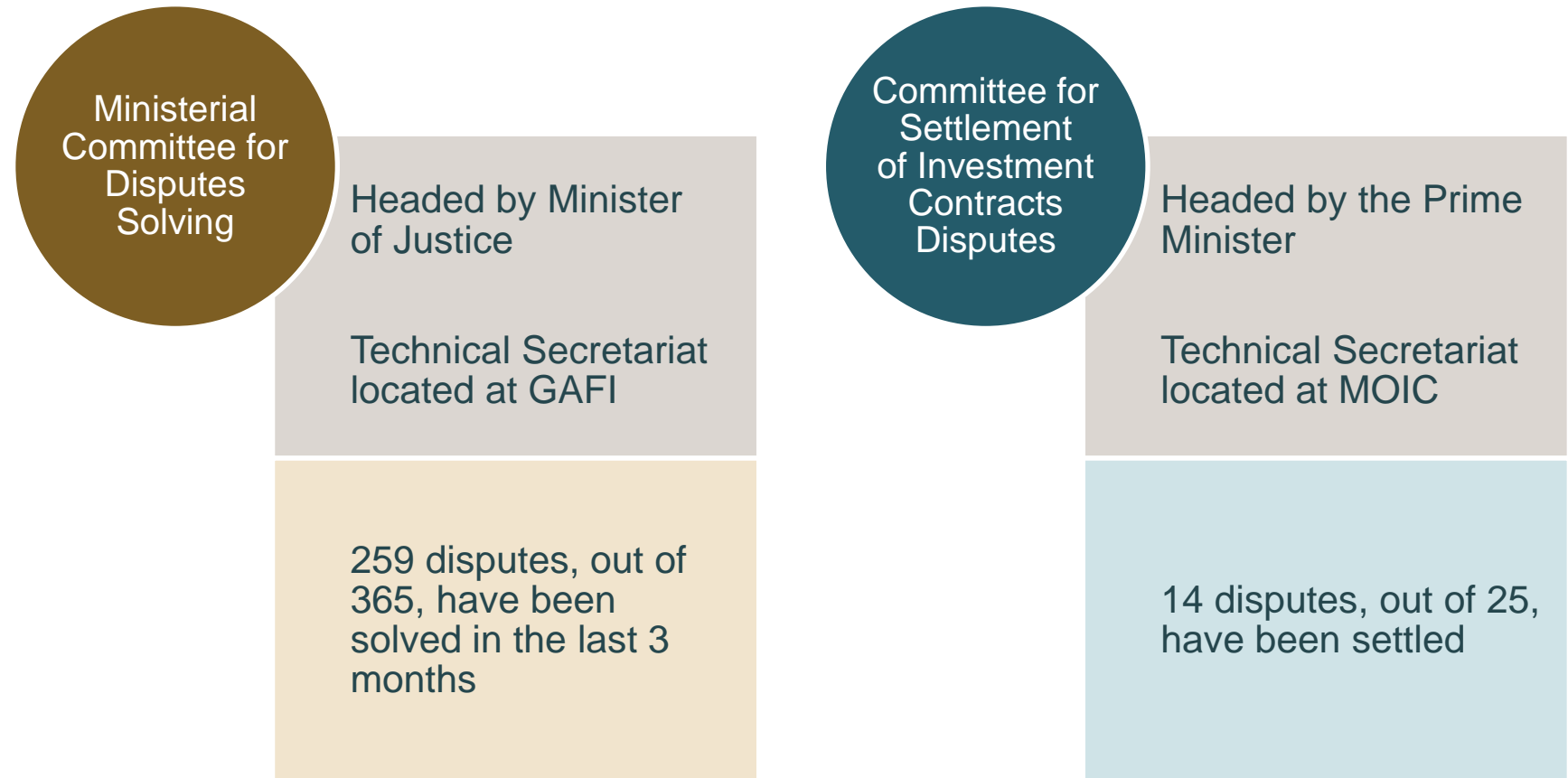
General Business Climate Issues

- Difficulty in **starting new investment projects**, with investors dealing with separate government entities
- Difficulty in **liquidating companies**
- Concerns on **land allocation mechanisms** and possible disputes that it could lead to
- Significant number of ongoing **investor disputes**
- **Mining sector** currently not seen as attractive by investors
- **Delay in payments** (arrears) by the government to business partners (e.g. oil and gas companies)
- Potential **conflict of interest** for some **regulatory bodies** who also have an operating role (e.g. EGPC)
- Concerns over Egypt's **capacity to become energy self-sufficient**

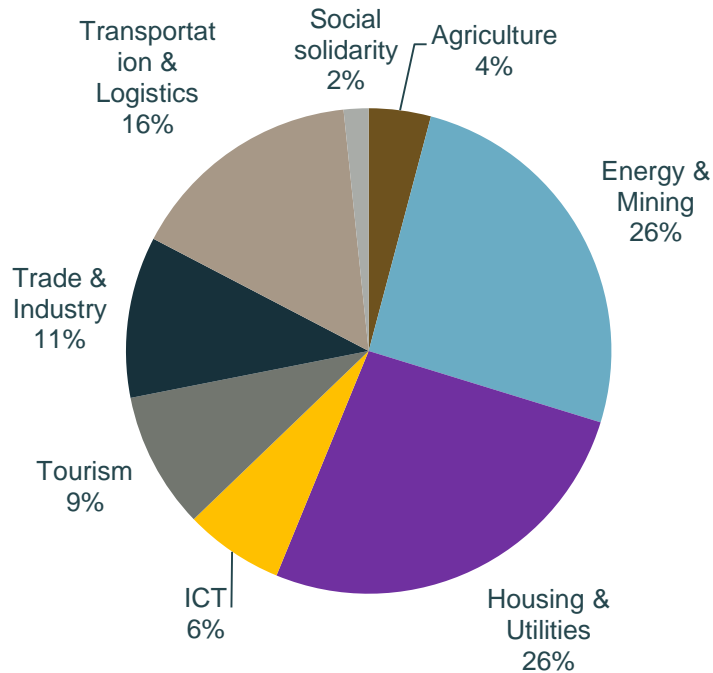

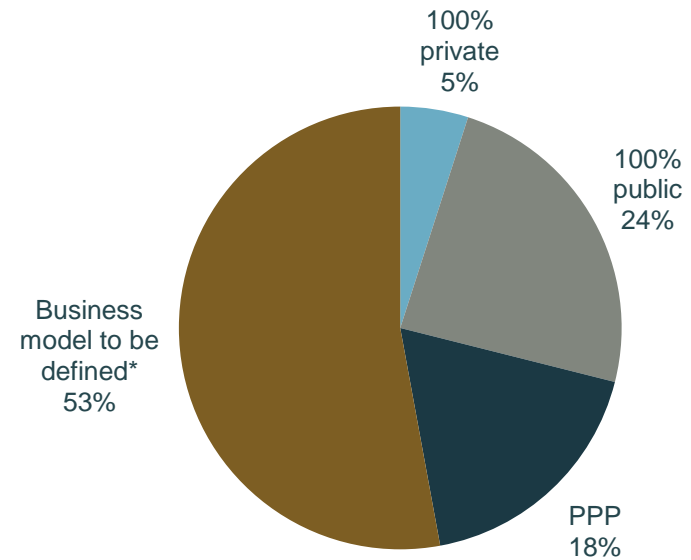
SCREENED PROJECTS BY SECTOR
