Public Establishment for Transmission of Electricity announces its need for the Design , Manufacture, Supply, Transport, Insurance, Execution of civil and electrical works, Erection, Testing, Putting into service, Guarantee, Training personnel from PETE, Submitting the spare parts and the necessary tools for execution of Al-Salamieh 230/66/20 kv new external substation in Hama ( turn-key job ) according to the conditions specified in the file of the external call for offers No 4/ 2017 which is published on the website of Public Establishment for Transmission of Electricity (WWW.PETE.GOV.SY).
