Enhancing Economic ties between the UK and Cyprus

The Cyprus Chamber of Commerce and Industry and the Ministry of Energy, Commerce, Industry and Tourism are organising in co-operation with the Cyprus-UK Business Association and OEB, a Business Delegation to London between 6-8 November 2017 (event will take place on 7 November 2017), aimed at the broad promotion of business relations between the business communities of the two countries.

The event will have the format of a Black Tie Dinner Speech with a key note speech by H.E. Mr George Lakkotrypis Minister of Energy, Commerce, Industry and Tourism. An exclusive guest list will be used for the UK participants and attendance will be by invitation only so as to ensure that only high calibre UK businesspeople will attend.

By attending, the Cypriot delegates will take part in a welcome networking reception, the speech and the dinner.
