Αγαπητά Μέλη,

Σας αποστέλλεται το έντυπο αίτησης του Export Helpdesk το οποίο μας στάληκε από το Υπουργείο Ενέργειας, Εμπορίου και Βιομηχανίας.

Το έντυπο σας αποστέλλεται για τυχόν εκδήλωση ενδιαφέροντος για προώθηση των εξαγωγών των κυπριακών προϊόντων και υπηρεσιών σε χώρες που καλύπτει το EHD. Η Υπηρεσία αυτή λειτουργεί από τον Σεπτέμβριο του 2015 και έχει στόχο την εξεύρεση συνεργατών (εισαγωγέων) για κυπριακές εταιρείες μέσω κυρίως των Εμπορικών μας Κέντρων στο εξωτερικό.

Σε ότι αφορά τις χώρες που καλύπτουν τα Εμπορικά μας Κέντρα σημειώνεται ότι τα Εμπορικά μας Κέντρα έρχονται και σε επαφή με δυνητικούς εισαγωγείς ενώ για τις χώρες που δεν καλύπτονται από τα Εμπορικά μας Κέντρα χρησιμοποιούμε κάποιες βάσεις δεδομένων για αποστολή στοιχείων εταιρειών στις κυπριακές εταιρείες έτσι ώστε οι κυπριακές εταιρείες να έρθουν κατευθείαν σε επαφή με τους δυνητικούς εισαγωγείς για ορισμένα προϊόντα και υπηρεσίες.

Όπως μας ενημερώνει το Υπουργείο μετά την παραλαβή των αιτήσεων θα γίνει σχετική επικοινωνία με τις ενδιαφερόμενες κυπριακές εταιρείες για να διοργανώσουν συναντήσεις μέσω zoom μεταξύ των ενδιαφερόμενων εταιρειών, λειτουργών του ΕΗD και τα Εμπορικά μας Κέντρα τα οποία στη συνέχεια θα προσπαθήσουν να εξεύρουν αγοραστές στο εξωτερικό.
