The Delegation will be headed by the Minister of Energy, Commerce and Industry Ms. Natasa Pilidou.

- 1. The focus themes for the event(s) will be set based on the interests of the Cypriot companies participating, following consultation with our Saudi counterparts. Thus, the relevant Agenda and travel information will be provided at a later stage but well in advance of the events.
